



# Date of report: 07/19/2014 (Saturday) for cases presenting on: 07/18/2014 (Friday)

# Summary

# Key findings

- Five of the 11 (45%) sentinel sites reported for July 18, 2014. Surveillance forms from 5 sentinel sites could not be collected due to weekend closure.
- Of the 5 sentinel sites that reported, 3 (60%) reported syndrome cases.
- 13 out of the total 139 encounters (9.4%) were reported as syndromes.
- 4 of the 8 (50%) syndromes were reported.
- 8 cases of watery diarrhea (median 14.5 y; range 2-86 y); 3 cases of influenza like illness (mean 1 y); 1 case of acute fever and rash (14 y); and 1 case of non-watery diarrhea (28 y) were reported. The remaining 4 syndromes had 0 cases reported.
- 9 of the 13 (69.2%) syndromic cases were females.
- 1 case of watery diarrhea tested positive for *E. histolytica*.
- No unusual occurrence reported from the 5 reporting sentinel sites.

### Conclusion and recommendations

- Watery diarrhea syndrome exceeded the daily threshold of 1 case for the state. Thus, an investigation will commence soon.
- Further training and clarification on the case definition for watery diarrhea at each sentinel sites.

Detailed analysis (for any syndrome that equals or exceeds set state daily threshold and, following confirmation of cases, it is decided to undertake an investigation)

#### Syndrome: Watery diarrhea and AFR

Point of care: Pohnpei State Hospital, Pohnpei CHC, and Genesis Hospital

**Date of investigation:** A thorough investigation will commence on Monday, July 21, 2014. Currently, sentinel sites are advised to collect specimens meeting the case definition of watery diarrhea. Specimen testing for *V. cholera* is recommended to all laboratories. **Description of investigation undertaken:** 

#### Findings of investigation:

Diagnostic methods, number of samples collected, number of samples tested, laboratory involved: Stool examination of 1 specimen of watery diarrhea case showed *E. histolytica* from Genesis Hospital.

*Time/Place/Person/clinical features*: Median age for all 8 cases was 14.5 years (range 2-86 years). 5 out of the 8 cases (62.5%) were females. All cases were residents of Pohnpei, FSM. Cases were from 4 (of the 6) municipalities of Pohnpei state, with 50% (n=4) of the cases from Nett municipality.

#### Measures taken or considered:

Public health measures (e.g. immunisation strategy, patient and contact management, vector control, water and food safety): Point of care staff were advised to promote and increase awareness on good hygiene techniques, including hand washing. These messages were also reinforced through the strategic health communication campaign, including through posters, radio messages, and promotional messages. EPA recommended to make hygiene and sanitation spots checks with recommendations to Organising Committee for any remedial action.
